**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Pate Mesi Lomdak on **24/01/2024**, filed an RTI application under Form-'A' before the PIO-Cum- SE, Power Circle V Ziro, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **01/03/2024**, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/04/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No .178/2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for six times i.e on **11/06/2024, 06/08/2024, 05/09/2024/04/02/2025, 08/04/2025 & 09/09/2025** d

**Details of information sought by the Appellants.**

1. Total no. of vacancy posts/sanctioned posts under various groups' viz. Group-'B' 'C' &'D' etc.
2. List of persons who were appointed under various groups viz. Group-'B', 'C' &'D' etc. on officiating/ Contract/Contingent/Ad-hoc basis, clearly indicating the year and mode of their appointment along with their Educational Qualification Certificate.
3. Whether the posts were advertised through any local daily? If yes, name of the NewsPaper, mentioning the date of their advertisement, along with the copy of the same.
4. Copy of initial appointment order of group 'B', 'C', & group 'D' Employees who were appointed on officiating/ Contract/Contingent /Ad-hoc/temporary/Compensate ground etc. basis.
5. Copy of the relevant Recruitment Rule (RR), governing the service appointment and service condition of all trade viz. Peon, Chowkidar, Wireman, Lineman, Electrician, Meter Reader, Computer Operator, LDC, UDC, Typist, Driver, Handyman, Sweeper etc. Copy of Relevant recruitment rule (RR), governing the service appointment on compensate ground and service term and condition thereof.
6. Copy of Regularization Order of group "B", "C", & group "D" Employees, if any of them has been regularized after their initial appointment.
7. Whether there were any recommendations from any Minister/MP/ MLA in favors of any candidate for appointment/regularization to all group "B" & group "C" & group "D" post respectively as aforesaid? If yes, than the copy of their recommendation or note sheet may be
8. Seniority name list of the meter Reader, Electrician, Wireman, Lineman, Chowkidar, Gate Keeper, Computer Operator, LDC, UDC, Driver, Handyman, Peon, Sweeper, typist etc.
9. Guidelines and policy adopted by the department for the promotion of, Chowkidar, Gate Keeper, Store keeper, Computer Operator, LDC, UDC, Driver, Handyman, Peon, Sweeper, typist etc.
10. Guidelines and policy adopted by the department for the appointment of contingent staff.

11. Name list of Chowkidar, Gate Keeper, Store keeper, Computer Operator, typist, LDC, UDC, Driver, Handyman, Peon, sweeper, etc. whose service has been promoted to regularization.
12. Furnish the name list of Chowkidar, Gate keeper, store keeper, computer operator, typist, LDC, UDC, Driver, handyman.

In the 6<sup>th</sup> hearing on 9<sup>th</sup> day of Sept '2025, the Appellant found absent but with a letter dated 09/09/2025 during the hearing. The PIO -cum, Chief Engineer (WZ) found absent during the hearing without intimating the reason for his inability to attend the hearing.

However, the Appellant Shri Pate Mesi Lomdak has submitted a letter to the Commission on 09/09/2025 stating that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of this appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.


