JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Taro Moising on 24/12/2024, filed an RTI application under Form-'A' before the PIO-Cum-Deputy Commissioner Papum-pare, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27/01/2025, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 28/02/2025 and the Registry of the Commission, having receipt of the Appeal registered it as APIC No. 219/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission 1st i.e on 08/07/202, details of information(s) sought from the PIO.

Details of Information required;

- Furnish the name of Managing Trustee by the Governing Council for Bank A/c of i) Trustee with Seal and Signature.
- Furnish the name & details of board members who are involved in DMF(T) with seal ii) and signature.
- Furnish the details of fund utilization. iii)
- Furnish the Administrative approval copy for the fund released. iv)
- Furnish the photocopy of administrative team during the time of site visit. V)
- Furnish the details of Geo-Tag vi)
- Furnish the details of the time to time audit and budget report. vii)
- Furnish the hard copy of the Annual Report which is submitted to the State Govt. viii)
- Furnish the copy of Demand Draft and Treasury Challan during the time of deposited ix) to the DMF(T) account.

4. I state that the information sought does not fall willing the restrictions contained in Section B of the Act and to the best of my knowledge it pertains to your office.

5. A fee of Rs./-has been deposited in the office of the Competent authority vide Treasury Challan / IPO No.66-808414dated: 24-16-20

iii) Period for which Information required: 2020 to till date
