JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Taro Moising on **24/12/2024**, filed an RTI application under Form-'A' before the PIO-Cum-Deputy Commissioner Papum-pare, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27/01/2025, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/02/2025** and the Registry of the Commission, having receipt of the Appeal registered it as **APIC No. 219/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission 1st i.e on **08/07/2025**, details of information(s) sought from the PIO.

Details of Information required;

- i) Furnish the name of Managing Trustee by the Governing Council for Bank A/c of Trustee with Seal and Signature.
- ii) Furnish the name & details of board members who are involved in DMF(T) with seal and signature.
- iii) Furnish the details of fund utilization.
- iv) Furnish the Administrative approval copy for the fund released.
- v) Furnish the photocopy of administrative team during the time of site visit.
- vi) Furnish the details of Geo-Tag
- vii) Furnish the details of the time to time audit and budget report.
- viii) Furnish the hard copy of the Annual Report which is submitted to the State Govt.
- ix) Furnish the copy of Demand Draft and Treasury Challan during the time of deposited to the DMF(T) account.

4. I state that the information sought does not fall within the restrictions contained in Section B of the Act and to the best of my knowledge it pertains to your office.

5. A fee of Rs./-has been deposited in the office of the Competent authority vide Treasury Challan / IPO No.66-808414dated: 24-16-20

iii) Period for which Information required: 2020 to till date

In the final hearing on **8th day of July'2025**, the Appellant present in person before the Commission. The PIO found absent.

The Appellant Shri Taro Moising, has submitted a letter to the Commission, on **09/5/2025**, stating that he has received all the information(s) as sought in his Form 'A' application and have requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
