Information sought :

- The appellant filed an RTI Application dated 09/06/2025 seeking Details regarding
- Category of Work charged W/C serving under the Division & Sub0division.
 - Appoint letter, place of posting etc. of W/C staff under the division.
 - Present strength, new strength and sanction strength of W/C staff under the Division. Recruitment Rules and approval of the competent authority etc.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 15/07/2026. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Ashok Sangbia absent.
Respondent : PIO-cum-EE (PWD) Sagelee Division is represented by Er. H. Yarang, APIO.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ashok Sangbia on **09/06/2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Sagalee Division, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various

information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **15/07/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **26/08/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 662/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 09/02/2026 and 18/05/2026 In this hearing of the appeal on 18th day of May, 2026, the PIO-cum-EE (PWD), Sagalee Division is represented by Er. Haj Yarang, APIO but the Appellant Shri Ashok Sangbia found absent without any intimation to the Commission.

As per the last order dated 09/02/2026, last chance was given to the appellant to appear before the Commission in the next hearing. PIO has stated that the information sought had already been provided through Superintendent Engineer (PWD) to the appellant and the appellant had received the information provided. Receipt copy of the same is submitted before the Commission today. Sufficient chance is given to the appellant.

Therefore, the Commission presumes that the appellant is being provided all the information and is satisfied.

Therefore, this appeal case is disposed of and closed.
