Information sought :

The appellant filed an RTI Application dated 04/06/2025 seeking Details regarding appoint lists of contingency, Peon, W/c, Sweeper, Chowkider, Handiman, Cookman, Causal labours, Driver, Mechanical person, Computer operator, Computer Accountant, Cashier, Surveyor etc.

As per the case record, PIO had furnished all the sought information to the appellant.

Being dissatisfied, the appellant filed First Appeal dated 01/08/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Ato Sonam absent.
Respondent : PIO-cum-SE (Coord), RWD, W/Z, Itanagar absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ato Sonam on **04/06/2025** filed an RTI application

under Form-'A' before the PIO-cum-Superintendent Engineer (Coord), RWD, Western Zone, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **01/08/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **26/09/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 724/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three times i.e on 11/02/2026, 08/04/2026 and 25/05/2026. In this hearing of the appeal on **25th day of May, 2026**, the PIO-cum-SE (Coord), RWD, Western Zone, Itanagar and the appellant Shri Ato Sonam found absent without any intimation to the Commission.

On the last hearing dated 08/04/2026, PIO had brought all the information but due to absence of the appellant, documents could not be handed over to him. The appellant was directed to collect the information from the office of the PIO and intimate to the Commission but till date no intimation has been made by the appellant..

Appellant has been absent for the last 2 (two) consecutive times without any intimation to the Commission regarding his absence. Therefore, the Commission presumes that the appellant has received all the information and is satisfied.

The appeal case is therefore, disposed of and closed.
