**JUDGMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tako Heyo on **08/10/2025**, filed an RTI application under Form-'A' before the PIO-Cum- District Land & Revenue officer Tato Shi-Yomi, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **03/11/2025** the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **07/09/2025**, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 68/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission two times for hearing on **21/05/2026 & 30/07/2026**.

**The details of information as applied;**

- i) Please furnish the copy of the total amount of money sanctioned/approved for C/o Tato-I & Tato-II Hydro Electric Project by the competent authority/Govt. of Arunachal Pradesh.
- ii) Please furnish the copy of the Final Awards finalized by the Govt. of Arunachal Pradesh indicating the total amount of money for payment of land and assets compensation to the Project Affected families (PAFs) in connection with C/o Tato-I & II Hydro Electric project. to be constructed by NEEPCO.
- iii) Please furnish the copy of total list of the Project Affected Families (PAFs)/person owing to C/o Tato-I & II Hydro Electric project to be constructed by NEEPCO.
- iv) Please furnish the total amount of money paid to the Project Affected Family (PAFs) as on date after completion of land acquisition for C/o Tato-I & II Hydro Electric project to be constructed by NEEPCO.
- v) Please furnish the current status of the payment of land compensation to the project affected families (PAFs) as on date of Tato-1 & 11 Hydro Electric project showing name of the persons/families who have been paid land compensation and indicating the persons who are yet to receive land compensation against the project.

- vi) Please furnish the copy of the preliminary and final notification for land acquisition of the government for C/o of Hydro-Electric Project of Tato-1 & Tato-II.
- vii) Please furnish the copy of the handing & taking over of the land in between the NEEPCO and the Govt. of Arunachal Pradesh of Hydro-Electric Project of Tato-1 & Tato-II.
- viii) Please furnish the copy of the Power of Attorney given by the Project Affected Families pending issues.
- ix) Please furnish the copy of the joint survey report with details of assets conducted by the district administration/Land Assessment Board/Committee and the Project Affected Families for land and properties compensation of the Project Affected Families and duly signed by the PAFs/person including main and supplementary property/assessment Report.
- x) Please furnish the property and Assets assessment Report submitted by the various departments for preparation of compensation Assessment to the Assessment Board for construction of Tato-I & II Hydro Electric Project.
- xi) Please furnish the colour Photograph and video graph/drone survey of the each land and assets of the Project Affected Families indicating time and date with their respective Chainage number/GPC location in terms of meters or meter square.
- xii) Please furnish the list of the PAF who has filed objection and land disputes cases with regard to improper assessment or Illegal assessment of the land and properties for compensation.

In this 2<sup>nd</sup> hearing of the appeal on 30<sup>th</sup> day of July, 2026. The Appellant Shri Tako Heyo, present during the hearing and the PIO-cum- District Land & Revenue office (DLRSO), Shi-Yomi Govt of Arunachal Pradesh, present during the hearing through online mode.

**Heard the Appellant.**

The Appellant stated that the PIO has provided the complete information through whatapp messaging app yesterday on 28/07/2026, the information which was not provided earlier further, stated before the court that some of the information are illegible and therefore the Appellant requested for a copy of those information from the PIO which are legible /clear.

**Heard the PIO.**

The PIO-cum -District Land & Revenue office Tato,Shi-Yomi District, submitted that the legible information copies will be furnished to the Appellant provided the Appellant come in person to the office of the PIO and the rest remaining information have been sent as soft copy to the Appellant through whatapp messaging app on 28/07/2026.

**After hearing both the parties the Commission observe;**

1. The PIO has provided/furnished all the information to the Appellant to which the Appellant too has confirmed but some of the information are illegible for which the PIO has consented to provide legible copies to the Appellant.

2. While the information have been provided by the PIO to the Appellant certain *rectification in the information* copies are only needed for with another hearing is not warranted and therefore the Commission while ordering the PIO to provide clear copies of information which clear wording and images, which can be read by the Appellant, dispose of this appeal today.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.

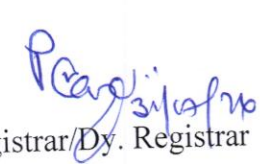
