JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Tagi Ruti on **23/06/2025** filed an RTI application in Form- 'A' before the PIO-cum-Executive Engineer (EE), WRD, Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **30/07/2025**, and even then, the Appellant not receiving the required information from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **23/09/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **759/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **24.02.2026 & 18.08.2026.**

In the second hearing the Appellant absent continuously for the second time, despite notice of hearing sent to him at his address as provided in the Form-A on 13.11.2025 and 24.02.2026.

In the second hearing of the appeal, the PIO-cum-Executive Engineer, WRD, Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh has submitted a letter to the Deputy Registrar, Arunachal Pradesh Information Commission (APIC) dated 26.11.2025, stating that the information as applied by the Appellant have been provided to the Appellant, and therefore, the Appellant is willing to withdraw his appeal through a letter dated 31.10.2025, addressed to the PIO.

In the absence of both the parties, while considering the letter of the PIO as well as the withdrawal of appeal letter of the Appellant, the Commission hereby dismiss this appeal and close it once for all.

In view of the above facts and circumstances the Commission dismiss this Appeal. And, accordingly, this Appeal stands dismissed and closed once for all.

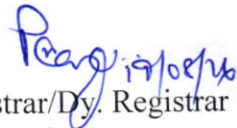
