JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Ratan Chetia on **17/01/2023**, filed an RTI application under Form-'A' before the PIO-Cum-EAC Changlang, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **7/05/2024**, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **15/07/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No.219/202(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for six times i.e on **12/08/2024, 03/10/2024, 30/01/2025, 03/04/2025 & 28/08/2025**, details of information(s) sought from the PIO.

Details of information sought by the Appellants.

- i) Furnish the names of all running Bricks, Tea, Coal Cook Factories (Cook Bhatta) and Stone Crushers with details of owners under your jurisdiction.
- ii) Furnish the CT copies of License with GST and CGSTIN No. of all the factories mentioned above.
- iii) Furnish the CT copies of Raw Coal purchase GST bill from registered company/Coal India Ltd. for running the Tea, Bricks and Coal Cook factories
- iv) Furnish the CT copies of GPS and Geo tagged coordination of all the factories.
- v) Furnish the CT copies of NOCs from forest department/NGT guidelines for establishment of all the factories
- vi) Furnish the LPCs of all the factories.
- vii) Furnish the CT copies of Raw Coal consumption and production capacities factory wise of all the factories
- viii) Period for which information asked for 2020 to till date

In the final hearing on **28th day of August '2025**, the Appellant present during the hearing through online mode. The PIO –cum, EAC Changlang found absent during the hearing.

However, the Appellant Shri Ratan Chetia, has submitted a letter to the Commission on **16/06/2025** stating that has received all the information(s) as sought in his Form 'A' application and have requested the Commission for disposal/closure of this appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.


