JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Chow Lajamang Mannow on **28/03/2025**, filed an RTI application under Form-'A' before the PIO-Cum- SE, Coordination (PWD) Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **06/05/2025**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22/08/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-648/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st hearing on **16/10/2025 & 24/02/2026**

Details of information sought by the Appellants.

1. Particulars of Information:- Shri Bini Sha, JE, PWD and Officiating/Functional AE of PWD, KAMLANG SUB-DIVISION.
 - i) Certified Copy of Office Order/OM/Notification of Shri Bini Sha, JE to serve as Officiating/Functional AE, PWD, KAMLANG SUB-DIVISION under PWD, NAMSAI DIVISION.
 - ii) Certified Copy of Notesheet/Recommendation letter from Minister/Advisor to HM/MLA in favour of Shri Bini Sha, JE PWD to serve as Officiating/Functional AE of PWD, KAMLANG SUB-DIVISION.
 - iii) Certified Copy of Govt Order/Notification to disallow Officiating/Functional Assistant Engineer by GoAP.
 - iv) Certified Copy of Seniority list of Shri Bini Sha, JE PWD.
 - v) Certified Copy of Office Order/OM/Notification that Junior Engineer can function as Assistant Engineer by Competent Authority.

In the 2nd hearing on 24th day of Feb '2026, the Appellant present during the hearing. The PIO –cum, Superintending Engineer (SE) Coordination Itanagar, found absent during the hearing without intimating the reason for his inability to attend the hearing.
