**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, Po/Ps Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(WRD), Roing Division, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 29/09/2025 regarding total list of Completed Plan & Non-Plan Works / projects sponsored by State fund / Central fund (such as SIDF/ BE/RE/ RIDF/SADA / ADA / MLA-LAD /SPA/ Article 275 (1)/ PMJVK/ CRIFK/ PMDeVINE/ NEC / NESIDS / Non-BADP /SASCI /FMBAP / PMKSY/ Maintenance works etc, executed under the division : from the financial year 2016-17 to 2025-26.
- 2). **The 1<sup>st</sup> hearing was held on 21<sup>st</sup> April' 2026.** Er. Kago Rubu, PIO -cum- EE(WRD), Roing Division, Lower Dibang Valley District, Arunachal Pradesh was present. The Appellant Shri Tamchi Gungte was absent.
- 3). The Appellant had submitted a letter dated 21/04/2026 requesting for another date of hearing, just twenty minutes before commencement of the hearing through a whatsapp message.
- 4). The PIO informed the Commission that the Appellant had sought vague and voluminous information, so he was asked to seek specific details; however, the Appellant did not agree to suggestion. The PIO further informed that the total lists of work were available and could be furnished if desired.
- 5). The Commission, decided to dispose of the case, as submission of letter for postponement at the eleventh hour, that too, on flimsy ground was not acceptable.

6). Therefore, the case is hereby disposed of.
