#### JUDGEMENT ORDER

-V/S-

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Tania June & Shri Nikam Dabu, C/o Post Office Naharlagun, Arunachal Pradesh, for non-furnishing of information, by the PIO-cum-DAO, Dept. Of Agriculture, Raga, Kamle District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 12.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Appointment of Agricultural Field Assistant (AFA) of entire Kamle district for the period 2007 to till Date."

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing for the case was held on the 15<sup>th</sup> of February'2023. The Appellant Shri Tania June was present but the PIO was absent. Therefore, the case couldn't be heard and the next hearing of this case is fixed on the 1<sup>st</sup> day of March'2023.

The 2<sup>nd</sup> hearing for the case was held on the 1<sup>st</sup> day of March'2023. The appellant was present but the PIO was absent. The PIO has been found absent for 02(two) consecutive times without any incitation and also, he has not deputed any representative to be present on his behalf. Therefore, a Show Cause Notice was sent to the PIO. The next date of hearing of this case is fixed on the 26<sup>th</sup> day of April'2023.

The 3<sup>rd</sup> hearing of the case was held on the 26<sup>th</sup> day of April'2023. The Appellant was present but the PIO was absent. Heard the case ex-parte. The next hearing of the case is fixed on the 10<sup>th</sup> day of May'2023.

The 4<sup>th</sup> hearing of this case was held on the 10<sup>th</sup> day of May'2023. Both the parties were present. Heard both the parties. The PIO informed the Court that he has provided all the information sought by the appellant and the appellant also informed the court that he has received all the information as sought by him from the PIO and expressed his satisfaction with the information provided by the PIO and pleaded for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
