



# ARUNACHAL PRADESH INFORMATION COMMISSION

An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-306/2025.

#### ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Lajamang Mannow for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PHE&WSD), Khonsa Division, Tirap District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17-12-2024.

A) Particulars of information: Project Integrated Drinking Water Project through hybrid of lift and gravity distribution system with value addition of Tourism components at Deomali, Tirap District, A.P. (under NESIDS).

- h. Certified Copy of name of the firms qualified in Technical Bid and participated in the Technical Bid along with Comparative Statement.
- i. Certified Copy of Board Members of the Tender Processing.
- j. Certified Copy of Bank Solvency Certificate of the firm who did the work/scheme.
- k. Certified Copy of Affidavit of having not more than 2 (two) works in hand under the State Govt. by the firm.
- 1. Certified Copy of GST Registration certificate, Income tax clearance certificate, latest Audit report of last 3(three) years duly certified /Audited by the Chartered Accountant of the firm who did the work/scheme.
- m. Certified Copy of Measurement book of the said work.

- n. Certified Copy of First and Final bill of the said work.
- o. Certified Copy of Cash Book Statements with page numbers or Give hand receipt with payee name of the said work.
- p. Certified Copy of details of payment done through Cheque/PFMS as mention the first and final bill.
- q. Certified Copy of Photograph with (GPS) Coordinates /Geo-tag of the said work, before starting, ongoing and after completion of the said work /scheme.
- r. Certified Copy of Design and Growing of the work/scheme.
- s. Certified Copy of Utilization and Completion Certificate of the said work /scheme.
- t. Certified Copy of the EE/AE/JE who executed the said work/scheme/project.
- u. Certified Copy of Status of the work, if not completed give the specific reasons not completed.
- v. Certified Copy of duration of completion of the said work/project as per agree and extension duration of the said work.

# (C) Period for which information asked for: 2022 to date.

### Hearing and decision:

The appeal was heard on 20<sup>th</sup> August, 2025 wherein the appellant, Shri Chow Lajamang Mannow was present in person and the PIO, Er. Shri Bharat Sonam, EE was present via VC.

This Commission, upon hearing the parties and on perusal of the records particularly, the date of receipt of the RTI application by the PIO which was 23.12.2024 (as per tracking record of India Post) and his letter dt.06.02.2025 asking the appellant to deposit the cost of documents that was issued long after the expiry of the one month statutory period (expired on 22.01.2025), had endorsed the direction of the FAA to the PIO to provide the information free of charge in terms of section 7(6) of the RTI Act.

The PIO was, hence, directed to furnish the requested information to the appellant free of charge to be collected by the appellant from the o/o the PIO within 2(two) weeks from the date of receipt of the order dt. 21.08.2025 and intimate this Commission about the receipt of the documents for further consideration of this appeal.

The appellant, however, vide his letter dt.06.09.2025, intimated that he had collected the information/documents from the o/o the PIO but the PIO had furnished inadequate information and accordingly, pleaded for hearing the appeal again.

In view of the complaint of the appellant as above, this appeal is listed and heard again today on 03.10.2025 wherein the appellant is present in person and Er. Shri Taring Mompak, AE and the APIO o/o the Executive Engineer (PHE & WSD), Khonsa Division is also present with the documents/information as requested by the appellant.

This Commission perused the documents brought in by the APIO and handed over the same to the appellant who, after going through expressed his satisfaction.

In the premises as above, this appeal no longer requires further consideration and is, accordingly, disposed of and closed.
