**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office, E-sector Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-BDO, Mebo CD Block, East Siang District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 20.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work/ Sanction Order/ Complete Work from 2014 to till date. “**

**The above subject has been mentioned in detail under 'Form – A'.**

The 1<sup>st</sup> hearing for the case was held on the 22<sup>nd</sup> day of November'2023. The appellant was present but the PIO was absent. A 2<sup>nd</sup> Summon Notice was issued to the PIO for his personal appearance on the next date of hearing of this case. The next date of hearing of this case is fixed on the 20<sup>th</sup> day of Dec'2023.

The 2<sup>nd</sup> hearing of this case was held on the 20<sup>th</sup> day of December,2023. The appellant was present but the PIO was absent. Therefore, the case couldn't be heard. The next of hearing of this case was fixed on the 17<sup>th</sup> day of January'2024.

Later on, the 09<sup>th</sup> January'2024 the appellant sent an application through WhatsApp (copy enclosed for ready references) stating that he had received all the information as sought by him from the PIO and he is fully satisfied with the information provided by the PIO and further pleaded before the Court for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.


