## JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Nima Sangcho, H-Sector, Near Arunodhaya School, Itanagar, ICR, Arunachal Pradesh, for non-furnishing of information, by The PIO-cum-Executive Engineer, Rural Works Department, Bameng Division, East Kameng District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 18.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"(PMGSY) Kojo to Nabolong Village Stage-II".

The above subject has been mentioned in detail under 'Form - A'.

The 1<sup>st</sup> hearing was held on 08<sup>th</sup> day of February' 2023. Both the parties were present. Heard both the parties. The PIO had pleaded before the Court to grant him few days time to furnish the information sought by the appellant. Hence, the Court fixed another date of hearing for the case on 01<sup>st</sup> March' 2023.

The 2<sup>nd</sup> hearing was held on 01<sup>st</sup> day of March' 2023. The appellant was present but the PIO was absent. The case was heard ex-parte. The appellant submitted a letter to the Court whereby expressing his satisfaction for all the documents furnished by the PIO and pleaded before the Court to dispose of the case. As such, the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
