<u>ORDER</u>

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sangkung Jonah, c/o DDSE Koloriang, District Kurung Kumey, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., O/o Directorate of Elementary Education, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 27/11/2024 regarding DPC & seniority list of all TGT.

2). The 1st hearing was held on 1st April, 2025 as scheduled. Shri Tani Talom, the PIO-cum JDEE (EE), Govt. of A.P., O/o Directorate of Elementary Education, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Shri Sangkung Jonah, were present.

3). The Appellant submitted that the PIO had furnished incomplete information. The Appellant also informed the Commission that he was inducted as PRT in the year 2004. DPCs were conducted in the year 2010, 2012, 2017 and 2023. Requisite documents like BA, Bed certificates were submitted in the year 2010. Till date he has not been promoted, though his batch and juniors have got promoted.

4). The PIO submitted that the Appellant had been furnished with information as sought by him. However, as per the claim of Appellant regarding the reasons for not being promoted, the PIO gave his assurance to delve into the matter and furnish the requisite information to the Appellant.

5). The Commission after hearing arguments from both the parties directed the PIO to furnish information to the Appellant within one months' time. In case information are not traceable or available, the PIO should give statement on AFFIDAVIT.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action against the PIO under section 20(1) the RTI Act-2005. In case Appellant is found absent the case shall be disposed of without any further notice.

7). The next date of hearing is fixed on 6th May, 2025 (Tuesday) at 1100hrs.
