Summon Order

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono, Vill-Sood, Naharlagun, P.O/P.S-Naharlagun, Arunachal Pradesh for non-furnishing of information by the PIO, O/o the DAH & VO Bomdila, West Kameng District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The last hearing of this case was held on 20th March,2024 (Wednesday). Dr Pema Thungon, VO Warjung-cum-APIO has represented the PIO and the Appellant Shri Mamu Sono was also present. The representative of the PIO has informed the Commission that the appellant did not report to the PIO's Office for site inspection as directed by the Commission in its previous hearing on 24/01/2024. The appellant informed the Commission that due to accident of his vehicle he could not reach the PIO's Office on time, however, he would reach Bomdila on 15th May,2024 for site inspection the date which has already been agreed to by the APIO Dr Pema Thungon. In view thereof, the Commission instructed both the parties to carry out the site inspection on 15th May,2024 and submit its report to the Commission.

The next date of hearing of this case is fixed on 22nd May,2024 (Wednesday) at 1030 hrs.
