WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 848/2025**, your personal appearances required before the Commission on **11th August 2026 at 02:30 PM**. The 2nd hearing held on **2nd June' 2026**. The Appellant Shri Ratan Chetia is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, (Shri AK Yadav) WRD, Bordumsa Division, Changlang District, Govt. of Arunachal Pradesh, found absent during the hearing, without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Heard the Appellant;

The Appellant stated that the PIO has not provided him any information till today despite the order from the Arunachal Pradesh Information Commission on 17th day of March' 2026 to provide all the information to him and on the same day of the hearing, the PIO's representative Shri Deo Sangno JE, WRD Bordumsa Division had submitted before the court that all the information will be provided to the Appellant on or before the next date of hearing, which is today.

After hearing the Appellant and taking the absence of the PIO seriously the Commission hereby orders;

- i) To issue bailable warrant of arrest against the PIO-cum-Executive Engineer, (Shri AK Yadav) (WRD) Bordumsa Division, Changlang District, for securing his attendance in the Third Hearing of this appeal, which is fixed on 11th day of August' 2026 at 2:30 PM.

- ii) To issue order to the Officer-In-Charge, Bordumsa Police Station, Changlang District, for executing the bailable warrant of arrest and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **11.08.2026, at 2:30 PM, without fail**, before this court.
- iii) The copy of this bailable warrant of arrest be served to the Superintendent of Police, Changlang District for compliance.
- iv) The copy of this bailable warrant of arrest be served to the Deputy Commissioner, Changlang District for compliance.
- v) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 11th day of August' 2026 at 2:30 PM (Evening).
