ORDER

The 2nd hearing held on 1st April, 2025 related to the APIC No-156/2024. The Appellant Shri Mamu Sonu is present. The PIO is not present during the hearing, but later on after the next case was called on, the PIO represented by his APIO presented himself before the Commission.

Heard the Appellant and the APIO;

The Appellant stated before the Commission that despite the order of this Court on dated 28.01.2025, the PIO has failed to provide the information(s) to the Appellant.

Heard the APIO:

The APIO (Shri Achung Gyadi) who reached the court of the Commission after the next case was called on, upon hearing him stated before the Commission that this appeal is very old and already heard during the time of the last Commissioner Genom Takseng, and 36,000 (thirty six thousand) pages have already been provided to the Appellant and the Appellant having filed many application for the same information(s) and so, he might not be recollecting that the information(s) have already been given to him.

The Commission Observes; that the statements of the APIO is not convincing the Commission as no evidence provided. Therefore, the Commission decided to give a fair chance to hear the Appellant and the PIO together about the information(s) provided by the PIO and received by the Appellant.

The Commission hereby orders;

- i. Both parties to be present in the next date of hearing, and in time, so that the court process is not disarrayed.

The next date of hearing be fixed on 17th June, 2025' at 2:30 PM (Afternoon).
