<u>O R D E R</u>

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tajing Saroh, Vill, Sipeng, Jomlo, Circle, PO/PS Rumgong, District Siang, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-DDSE, Govt. of A.P. o/o of Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/11/2022 regarding certified true copy of the appointment order, appointment letter and official advertisement no. of the peon and MTS under education department of Siang District.

The 3rd hearing is held today on 6th February, 2024 as scheduled. Smt. Oyi Borang Tatak, the PIO-cum-DDSE, Govt. of A.P. o/o of Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh and the Appellant Shri Tajing Saroh are present. The PIO brought document during the hearing and handed over to the Appellant. The Appellant after receiving the document appealed the Commission to give time for verification of the same.

The Commission considering the appeal grants the Appellant time to go through the document and to intimate the PIO if any short fall in furnishing of the information within fifteen days from the date of issue of this order. The PIO is also directed to furnish complete, correct and authenticated information to the Appellant within seven days on receipt of any intimation from the Appellant. If information are not available with the PIO, a justifiable reason has to be furnished in writing with seal & signature to the Appellant and intimation of action taken report has to be submitted to the Commission.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal action and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 9th April, 2024 (Tuesday) at 1030 hrs.

Therefore, Smt. Oyi Borang Tatak, the PIO-cum-DDSE, Govt. of A.P. o/o of Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
