SUMMON.

The 1st hearing held on **23rd day of July' 2026** related to the **APIC No-519/A/2025**. The Appellant Miss Bengia Mama is absent without reporting the reason for her absence during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), RWD, Laayang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh is present during the hearing before the Commission.

Heard the PIO;

The PIO stated that the information applied for the work by the Appellant has not been executed by his office but, the work was executed by the Executive Engineer, RWD, Koloriang Division, and therefore, he has forwarded the Form-A of the Appellant to the competent PIO-cum-EE, RWD, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh on 03.06.2026 through Registered Post.

- ii) The PIO-cum-EE, RWD, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh is impleaded as the respondent PIO from today in this appeal.
- iii) Send Summons to the PIO-cum-EE, RWD, Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh to attend the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.

- iv) Notice for next date of hearing be sent to the Appellant to attend the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte, by way of disposing this appeal.

The Commission hereby orders;

The next date of hearing be fixed on 1st day of October' 2026 at 10:30 AM (Morning).
