ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ganpho Khusumchai, Medical Colony, Longding, Longding District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(RWD), Govt. of A.P., longding, Longding District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/05/2023 regarding **C/O Approach road Govt. Sec. School Longding.**

The 2nd hearing is held today on 26th March, 2024 as scheduled. Shri Tumi Bagra, the PIO-cum-EE(RWD), Govt. of A.P., longding, Longding District, Arunachal Pradesh and the Appellant shri Ganpho Khusumchai are absent.

The Commission viewed seriously the absence of the PIO without any prior intimation to the Commission and willful absence from performing the statutory duty. In view of the facts and circumstances, the PIO is hereby given reasonable opportunity to appear before the commission and also **directs** Shri Tumi Bagra, the PIO-cum-EE (RWD), Govt. of A.P., longding, Longding District, Arunachal Pradesh to **SHOW CASUE as to why penalty should not be imposed on him.** The respondent is also directed to send his written submission along with all the supporting document upon which he chooses to reply during the hearing at least seven days prior to the actual date of hearing.

Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the SPIO fails to appear the Commission shall impose penal provision under section 20(1) of the RTI Act and if Appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant has received the information and satisfied with the same.

The next date of hearing is fixed on 6th June, 2024 (Thursday) at 02:00PM.

Therefore, Shri Tumi Bagra, the PIO-cum-EE(RWD), Govt. of A.P., longding, Longding District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
