### SUMMON

**WHEREAS**, in connection with the APIC-No. 336/2025, your personal appearances required before the Commission on **17<sup>th</sup> March 2026 at 01:30 PM**. The 2<sup>nd</sup> hearing held on **4<sup>th</sup> November' 2025**. The Appellant Shri Nabam Nanu present during the hearing in person.

The PIO -cum Project Director (PD), Govt of Arunachal Pradesh is also absent without intimating to the Commission the reason for his inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties also has to attend court hearing when an appeal is preferred against him as per the provision of the RTI Act 2005, which is statutory duty binding upon the PIO.

#### **Heard the Appellant.**

The Appellant stated before the Commission that the PIO has provided him some information but the information provided by the PIO are in-complete.

After hearing the Appellant the Commission hereby order;

- i) The PIO to provide the complete information(s) pertaining to serial no. **14,15,16,18,19,24 and 25 to the Appellant**. The PIO to be present in the next date of hearing to answer the accusation of the Appellant without fail.
- ii) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing, **failing which necessary action as provision of the RTI Act 2005 shall be initiated against the PIO**.
- iii) The Appellant to be present in the next date of hearing **failing which his appeal shall be heard and determined ex-parte**.
- iv) The next date of hearing has been intimated to the Appellant as he is present during the hearing.

Due to absence of the PIO, the Commission could not proceed with the hearing of the appeal. **The Commission ordered;**

**The next date of hearing be fixed on 17<sup>th</sup> March'2026 at 1:30PM.(Evening)**
