**An Appeal Case U/S 19(3) of RTI Act, 2005**  
**Case No. APIC- 613/2025.**

**(Summon to appear in person)**

**(Or.5 R.3 of CPC)**

**APPELLANT** : Shri Nechang Kamki, Niti Vihar, Itanagar.  
**RESPONDENT** : The PIO, o/o the EE (RWD), Bameng Division, East Kameng.

**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nechang Kamki for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Bameng Division, East Kameng District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 02.05.2025:

**A) Particulars of Information:** C/o WRSB over Para River in between Tansang Yangfo and Domdila Tajo village at Paya Paling Point.

**B) Details of information required:**

1. Furnish Sanction order/copy.
2. Furnish Details Project Report (DPR).
3. Furnish Work order.
4. Furnish TS copy.
5. Furnish Geo Tagging details in coloring photos.
6. Furnish detail copies of Material Procurement of Challans.
7. Furnish Photograph of project before during and after the completion of the project in coloring photo.
8. Furnish Payment Cheque leaf/ PFMS/DBT transaction receipt copy.
9. Furnish MIS Report in coloring.
10. Furnish Notice Inviting Tender (NIT) details with NEWS paper cutting.
11. Furnish the Name of bidder with detail supporting documents of the same.
12. Furnish Name of all the tender participants with detail documents.
13. Name of the Officers involved in the said project.
14. Furnish a copy of Approved drawing & assurance letter from nearest NIT/ITI.
15. Furnish details on the grounds for rejection of the technical bids of all bidders who were disqualified in the evaluation process. This should include specific deficiencies or no compliances with the tender requirements.
16. Furnish copies of the contractor licenses of the selected bidders, including the date of registration and any relevant updates or renewals.
17. Furnish Completion Certificate.
18. Furnish Utilization Certificate.
19. Furnish details of monthly monitoring report with coloring photos of 3rd Party monitoring team during field visit.
20. Furnish all the documents in proper paging with CTC in each page and please to furnish within 30 days from the date of receipt as per RTI act otherwise the appellant is not liable to pay any fees as per sub-section (6) of the Section (7) of RTI Act 2005.

**C) Period for which information asked for: 2025.**



This appeal was heard 2(two) times earlier on 8<sup>th</sup> Oct., 2025 and 19.11.2025.

On 08.10.2025, this Commission, upon hearing the appellant, who reiterated his demand for the requested information from the PIO and on perusal of the information which were found not covered by any of the exemption clauses under section 8(1) of the RTI Act, directed the PIO to furnish the requested information/documents to the appellant within 1(one) month from the date of receipt of this Commission's order dt.08.10.2025 and report compliance therewith in the next hearing fixed on 19.11.2025.

On 19.11.2025, no one appeared from the o/o the PIO. The appellant who was present in person informed that the then E.E has since been transferred from the Division and a new incumbent EE has recently joined the Division.

In this regard this Commission in terms of the Govt. of A.P Office Memorandum issued by the deptt. of Administrative Reforms according to which the transfer of PIO/APIO does not require appointment of new PIO/APIO afresh for that office, directed the newly transferred and posted EE-cum-PIO, Bameng Division, vide order dt. 20.11.2025, to furnish the requested information to the appellant within 1(one) month from the date of this order and report compliance therewith in the next hearing on 19<sup>th</sup> Dec., 2025.

This appeal is, thus, listed for the 3<sup>rd</sup> time today on 19.12.2025 wherein the appellant, Shri Nechang Kamke is present in person but the PIO is absent without any intimation.

The absence of the PIO or any of his representatives in the hearing without any intimation has been viewed seriously by this Commission which, which if repeated, shall entail penal action under section 20 of the RTI Act. The hearing of this appeal is, thus, adjourned to 4<sup>th</sup> February, 2026 with the same direction as contained in earlier order dt.20.11.2025 for compliance and report therewith on 04.02.2026.

**NOW THEREFORE**, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC 4<sup>th</sup> February, 2025 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
