ITANAGAR. An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-168 /2025. (Summon to appear in person) (Or.5 R.3 of CPC)

ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive* Engineer, (WRD) Tezu Division, Lohit District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated: 11.11.24:

A) Particulars information: C/o "The total list of Project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile MsDP Scheme, Ministry of Minority Affairs Govt. of India" during the financial year of 2015-16.

B) The total List of Project are:

- 1. Certified Sanction Order Copy.
- 2. Certified DPR Copy of the projects mentioned above.
- 3. Certified copy of Proof (such as Voter ID and PRC) that the tender winning firm
- Domicile status within the Territorial jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015.
- 4. Certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
- 5. Certified copy of Utilization Certificate (UC) countersigned by the DC along with Executing Agency as per Sanction Order guidelines.
- 6. Certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
- 7. Certified Progress Report of the projects in physical and financial section till date counted signed by the DC of the Concern Dist. along with the Executing agency.
- 8. Certified copy of Completion certificate of the project.
- 9. Certified copy of Newspaper in which NIT was published (Atleast 3 newspaper name (one National & 2 Local) along with date of publication of Newspaper, as per Government approved order.

10. Certified Designed and Scope of work in the projects.

- 11. Certified copy of work Specification of the projects.
- 12. Certified copy of documents submitted by tender participant for Technical Bid.
- 13. Name of firms who won the tender work with respect to the subject mentioned above.
- 14. Name of officers and their Designation at the Time of monitoring the work.
- 15. Certified copy of contractor registration, of the tender participant and tender winning firm.
- 16. Certified copy of contractor Enlistment Update reports (Civil/ Composite Category as per the nature of work), of tender participant and winning Firm.
- 17. Certified copy of EMD and Security money deposited by all the tender participant.
- 18. Certified Integrity Pact submitted by the tender participant.
- 19. Certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/ she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (As per rule SPWD/W-66/2012 as per District Based Entrepreneurship Act, 2015).
- 20. Certified documents submitted by tender participant and winning firm, i.e copy of completed three similar work each of value not less than 40% of the estimate cost or completed two similar work each of value not less than 60% of the estimated cost or * completed one similar work of value not less than 80% of the estimated cost along with the completion certificate issued by the Engineer in charge duly countersigned by the concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
- 21. Certified copy of Acceptance letter for tender work by the Executing Agency to the tender winning firm.
- 22. Certified copy of work order given to the contractor by the Executing Department.
- 23. Agreement Copy made between the contractor and the Executing Agency for the projects mentioned above.
- 24. Certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy paper) after completion of work.
- 25. Geo Coordinate information for the work mentioned above.
- 26. Certified Payment Details (Cheque no, voucher, PFMS etc. (which ever method is used of payments) of the project till date.

This appeal is listed and heard for the 2nd time today on 02.07.2025, the 1st time being on 28.05.2-25 when this Commission, upon hearing the parties and perusing the records in the appeal endorsed the contention of the appellant that the PIO, o/o E.E, Tezu

Division ought to have transferred his RTI application to the o/o the E.E, Namsai as provided under sub-section (3)(i) of section 6 of the RTI Act and that the PIO, having not followed the procedure/law, should collect those requested documents from the o/o EE, Namsai and furnish to him.

This Commission, accordingly, had directed the PIO to collect the requested information/documents from the o/o the EE, Namsai Division which are being held by that Division and furnish them to the appellant in terms of sub-section(4) of section 5 and the EE, Namsai Division shall provide the documents to the o/o EE, Tezu Division as mandated under sub-section(5) of section 5 of the RTI. The hearing of this appeal was, thus, adjourned to 02.07.2025.

In compliance with the above direction, the PIO, o/o EE, Tezu Division, vide his letter dt. 18.06.2025, addressed to this Commission, forwarded the details of Bills under MsDP Schemes payable to certain firms against the 7 (seven) schemes). The PIO also attached in the said letter the copy of his letter dt.05.06.2025 addressed to the o/o the EE, Namsai Division seeking documents/information on 6(six) points.

In today's hearing the appellant, Shri Tamchi Gungte is present in person and the PIO, Er. Shri Debang Tayen, E.E attended through V.C.

Heard the parties.

The appellant, while reiterating his demand for the requested information, pleaded for direction to the PIO to furnish the remaining requested information, more particularly, the following :

1. Sl. No. 3 (Voter ID Card or PRC of the firm who won the tender;

2. Sl. No.4 (Technical Sanction);

3. Sl. No.5 (U.C duly countersigned by the Dy. Comm. Concerned);

4. Sl. No.7 (Progress Report);

5. Sl. No.8 (Completion Certificate);

6. Sl.No.15 & 16 (Contractor Registration and Contractor Enlistment);

7. Sl. No.17(copy of EMD & Security Money);

8. Sl. No.19(copy of affidavit regarding 2 or more incomplete work);

9. Sl.No. 20 (copy of certifictaes on completion of 3 similar works);

10. Sl. No.22 (copy of work order);

11. Sl.No.24 (photo graph of work before start and after completion);

12. Sl. No.26 (payment details such as Cheque counter-foil, voucher, PFMS etc)

The PIO on the other hand submitted that on bifurcation of the Namsai Division from the Tezu Division, most of the documents had been transferred to the Namsai Division for which he had already requested the o/o the E.E, Namsai Division for providing those documents. The PIO further submitted that besides taking up with the o/o E.E., Namsai Division, his office is still trying to trace out some of the requested documents which will require some more time and that whatever documents could be traced out, the same shall be furnished to the appellant.

This Commission, upon hearing the parties, directs the PIO to collate and collect the documents and furnish to the appellant within 4(four) weeks and report compliance in the next date of hearing which is fixed on 06.08.2025. The E.E, Namsai Division is also directed to provide the documents either directly to the appellant or to the o/o the EE, Tezu Division and report the compliance in the hearing on 06.08.2025 personally or through the APIO or any authorised official.

This appeal is, thus, listed on 06.08.2025.

NOW THEREFORE, the PIO-cum EE, Tezu Division and the E.E, Namsai Division are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on 6th August, 2025 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
