SUMMON

WHEREAS, in connection with the APIC-No. 348/2024, your personal appearance is required before the Commission on 05th February, 2026 at 10:30 AM. The 4th hearing held on 30th Sept '2025. The appellant Shri Riya Taram found absent during the hearing without intimating the reason for his inability to attend the hearing.

The PIO-cum- EE PHE &WS Koloriang Division, also found absent without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to the reminded that the PIO besides public duties, also has to attend the Court when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission ordered;

- To summon the PIO to be present in person before the Commission in the next date of i) hearing. Failing which necessary action shall be initiated against the PIO as per the RTI Act, 2005.
- The Appellant to be present, in the next date of hearing of this appeal failing which, ii) this appeal will be heard and determined ex- parte.
- (iii To send the copies of this order to both the parties.

The next date of hearing be fixed on 5th February, 2026 at 10:30AM.
