**A. Particular of information:** "c/o Deep Tube Well including energization at POI Agri fied at Rigo,"

**B. Details of information required:**

1. A copy of the Administrative Approval (AA) and Technical Sanction (TS) order, including the total sanctioned amount.
2. A copy of work order issued to the contractor and the name of the firm/contractor.
3. Certified photocopies of the Measurement Book (MB) entries related to this project (Showing depth of well, casing used electric connection etc.
4. Copies of all Running Amount (RA) bill and the final Bill paid to the contractor.
5. Documents/ certificates confirming the energization (electricity connection) of the tube well, including the transformer/ meter details and NOC from the power department.
6. A copy of completion certificate and the "Handing Over/ Taking Over" report.
7. Copies of the geo tagged photographs submitted by the department during the commencement, middle and completion stages of the project.
8. Provide the copies of correspondence between WRD and Power Department regarding the "energization" (electric connection) on tube well.
9. Material procurement challan etc.
10. A copy of Master Roll or Labor Payment records for the duration of the construction.
11. Physical progress Report.
12. Utilization Certificate.

**C. Period for which information is required:** from the date of sanction to the current date 2021-2026.
