WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 01/2026(C)**, your personal appearance is required before the Commission on **15th October 2026 at 10:30 AM**. The 2nd hearing held on **6th day of August' 2026**. The Complainant Shri Milli Tajum is represented by his legal counsel, Shri Niya Rebe with an authority letter and vakalatnama during the hearing before the Commission.

The PIO-cum-Deputy Director of School Education, Itanagar Capital Region (ICR), Papu Nalah, Papumpare District, Govt. of Arunachal Pradesh is absent without reporting the reason for his absence despite notice for hearing being served on 06.04.2026.

Heard the representative of the Complainant;

The representative of the Complainant stated that the PIO has not provided him any information till now.

In the absence of the PIO, the contention of the Complainant could not be ascertained, and therefore, the Commission hereby orders;

- i) Issue Warning Summons to the PIO-cum-Deputy Director of School Education, Itanagar Capital Region (ICR), Papu Nalah, Papumpare District, Govt. of Arunachal Pradesh to be present in the next hearing without fail, failing which he will be arrested and brought to the court of the Commission for hearing.
- ii) The Complainant to be present in the next hearing without fail, failing which this appeal will be heard and determined ex-parte.
- iii) Notice for the next hearing be sent to the PIO.
- iv) Notice for the next hearing need not be sent to the Complainant as he is present during hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 15th day of October' 2026 at 10:30 AM
(Morning).
