**An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 649/2023.**

APPELLANT : Shri Tamchi Gungte (General Secretary), Arunachal Pradesh Peoples' Right Forum APPRF), Near K.V-2 School, Chimpu, Itanagar (A.P)

RESPONDENT : The PIO, o/o the Executive Engineer (RWD), Govt. of A.P, Likabali Division, Lower Siang District (A.P)

SUMMON / ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte, for denial of information by the PIO O/o the Executive Engineer (RWD), Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.04.2023.

This appeal was listed and heard for the 9th time on 19.02.2025.

In the 7th hearing on 6th December, 2024 wherein the representative of the PIO, o/o E.E (RWD), Likabali Division, Er. Shri P.C. Yadav, ASW had brought in the duly certified information sought for by the appellant which has been handed over to the appellant who has been directed to go through the same and report his satisfaction or otherwise within one week from 06.12.2024 so that next date of hearing, if required, can be fixed.

As directed, the appellant, vide his letter dt. 18.12.2024 addressed to the PIO, o/o E.E (RWD), Likabali Division, with copy endorsed to this Commission, had intimated that documents furnished to him during the hearing are incomplete and not as per his RTI application.

This Commission, considering the mandate of the RTI Act to furnish complete and satisfactory information to an RTI applicant, this appeal was heard on 29.01.2025 for the 8th time. However, no one appeared from the o/o the PIO despite summon notice. The appellant who was present, reiterated his dissatisfaction as already communicated to the

PIO vide his letter dt.18.12.2024 and pleaded for direction to the PIO to furnish the documents in complete form as requested by him.

Since the PIO nor any of his representative was present, the hearing of this appeal was adjourned to 19.02.2025 and the PIO was directed to attend the hearing with the left out/complete information without fail to avoid penal action under the relevant provisions of RTI Act, 2005.

The appellant did not turn up on 19th Feb. 25 but the APIO, Shri P.C.Yadav, ASW was present with the left out documents with forwarding letter dt.14.02.2025 addressed to the Appellant, Shri Tamchi Gungte in respect of :

- (1) c/o 60 bedded Girls Hostel at Govt. Hr. School Likabali;
- (2) c/o 50 bedded Girls Hostel at Govt. Hr. School, Kamku, Likabali Block and
- (3) c/o replacement of existing School at ME School, Silli (8ACRs) in Likabali Block

This Commission, upon hearing the APIO, directed the appellant to go through the documents with the photographs of the completed projects and report his satisfaction or otherwise therewith to this Commission within 2 (two) weeks from the date of receipt of this order whereafter the next date of hearing, if required, shall be fixed and intimated to the parties.

In compliance with the Commission's order dated 19th February, 2025 the appellant has submitted a letter dated 26.03.2025 wherein he has expressed his dissatisfaction and has informed this Commission that despite Commission's order dtd. 19th Feb. 2025 the APIO/PIO has not complied with and the appellant has further requested to fix another date for hearing so that he can get the remaining information / documents from the PIO/APIO.

In the premises as above, this Commission deems it necessary to hear the appeal again. The PIO o/o the Executive Engineer (RWD), Likabali Division, Dist : Lower Siang (A.P) is, therefore, summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on **23rd April, 2025 (WEDNES DAY) at 10:30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

NOW THEREFORE. Take notice that, in default of your appearance, on the day mentioned above, the matter will be heard and determined in your absence.
