**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 30(thirty) point information on "Augmentation of water supply System at Daporijo Township in Upper Subansiri District" sanctioned under NESIDS-ORTI during the financial year 2024-25 by the PIO, o/o the Executive Engineer (PHE & WS), Daporijo Division, Upper Subansiri District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 29.04.2025.

**Facts emerging from the appeal:**

Records in the appeal reveal that in response to the appellant's RTI application the PIO vide his letter dtd. 30.06.2025 had furnished the information to the appellant as under:

" Sir,

Records further reveal that the appellant being dissatisfied with the response of the o/o the PIO as above, filed his 1<sup>st</sup> appeal under section 19(1) of the RTI Act before the C.E, Central Zone, Aalo vide Memo of Appeal dt.09.06.2025 and in response thereof the C.E, Central Zone, Aalo, the First Appellate Authority (FAA) heard the appeal on 03.07.2025 and held that the information as sought by the appellant under RTI Act has to be furnished to the appellant. The appellant has, however, submitted that the PIO has furnished the information on the day of hearing itself and after going through the information at his home he found that the information provided is incomplete and hence has the appellant preferred his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act 2005 vide his memo of appeal dt.11.07.2025.

**Hearing and decision:**

This appeal is, accordingly, listed today on 14.11.2025 wherein the PIO, Er. Shri Dulom Tago, EE (PHE & WS), Daporijo Division is present in person but the appellant, Shri Tamchi Gungte is absent without any intimation.

Heard the PIO who produced a copy of his letter dt.10.11.2025 addressed to the appellant by which he reiterated his earlier replies as reproduced above and also containing additional replies to the rest of the queries numbering from Sl. No.10 to 31.

This Commission on perusal of the additional replies furnished by the PIO noticed that against some of the queries, the replies have been given as "N.A". It is pertinent to apprise the PIO that it is the requirement of law {section -7(8)(i) of the RTI Act} that when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his satisfaction. And as mandated by section-18(3)(c) and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, the submission/reply of the PIO has to be declared/supported by way of an affidavit.

The PIO is, therefore, directed to furnish the replies to those points by way of an affidavit instead of merely, "N.A".

In the absence of the appellant, it could not be confirmed as to whether he had received the said letter 10.11.25 in view whereof this Commission deems it appropriate to adjourn the hearing of this appeal to 21.01.2026 so that the appellant could be heard and consider the appeal further. It is, however, made clear that if the appellant fails to appear in the next date, this appeal shall be closed without any notice as being not interested by him.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
