ORDER/SUMMON

The 4(four) appeals were registered and heard in this Commission on different dates on 07.11.2025, 21.11.2025, 08.10.2025 and 28.11.2025.

The PIO, Koloriang PWD Division was directed, vide order dt. 29th May, 2026to, to furnish the left out information/documents as sought for in all the 6(six) appeals namely, APIC-366/25, APIC-367/25, APIC-368/25 and APIC-369/25, APIC-703/25 and APIC-704/25 to the appellant as soon as the documents are received back from the CBI. The appellant was also directed to intimate this Commission within 1 (one) week of the receipt of the same from the PIO for further consideration of the appeals.

As directed, the appellant, vide letter dt. 26.06.26 furnished a copy of EE, (PWD), Sangram Division's letter dt.06.06.26 to the EE, (PWD), Koloring Division returning the Measurement Book and other documents which were taken from the Koloriang Division for CBI enquiry.

This Commission upon perusal of the letter dt.06.06.26 from the EE (PWD) Sangram Division, directed the PIO, Koloriang Division, vide order dt.06.07.26, to furnish whatever documents are available or the affidavit in respect of those queries where no information are available in terms of section 7(8)(i) r/w section 18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005 pertaining to all the aforementioned 6 appeal and report the compliance thereof to this Commission on 05.08.2026.

Today on 05.06.26, the appellant is absent without any intimation. But the PIO, Koloriang Division is represented by his PA, Shri Lodar Nikja with a letter dt.03.08.26 from the PIO stating that the information/replies to the appellant in respect of the 5(five) appeals are being furnished vide letter dt.03.08.26 in the hearing today. The PIO also assured that the replies/reasons for not furnishing some of the information/documents shall be furnished on an affidavit.
