





ARUNACHAL PRADESH INFORMATION COMMISSION ITANAGAR.

An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-23/2025. (Summon to appear in person) (Or.5, R.3 of CPC)

APPELLANT

: Shri Tamchi Gungte, Near KV-II School Chimpu.

RESPONDENT

: The PIO, o/o the Executive Engineer, PHE &WS, Likabali Division, District Lower Siang A.P.

SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, PHE & WS, Likabali Division, District Lower Siang (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 08.08.2024.

A) Particular of information: The total list of project sanctioned under Pradhan Mantri Jan vikas Karyakaram (PMJVK), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India during the Financial year of 2019-20.

B) Details of information required:

- 1. Certified Sanction Order copy of the total list of project mentioned above;
- 2. Certified DPR copy of the projects mentioned above;
- 3. Certified copy of utilization certificate;
- Certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above;
- 5. Certified copy of newspaper in which NIT was published (At least 3 news paper name (one national & 2 Local) along with date of publication of news paper;
- 6. Tender Evaluation copy along with the list of Firms participated in the tender processed for the work;
- 7. Name of firm who won the tender work;
- 8. Certified copy on which date the project has been started;
- 9. Certified copy of completion certificate;
- 10. Certified payment details made through PFMS under DBT only;
- 11. The Geo Coordination information for the work mentioned above;
- 12. Certified photograph of worksite (glossy paper) before starting of work and after completion of work;
- 13. Name of Officers and their designation at the time of monitoring the work.
- 14. Certified full agreement copy made in between the executing agency and the firm owner;

- 15. Certified copy of Contractor Registration, trading licence, GST No., GST Return 3 B filled for previous tax period and
- 16. Certified copy of contractor enlistment update reports of tender winning firm.

This appeal was heard on 9th April, 2025 wherein the Appellant, Shri Tamchi Gungte was present in person and the PIO, Er. Shri Binga Gara, E.E (PHE & WS), Likabali Division attended the hearing through VC.

The appellant submitted during the course of hearing that he had received some documents from the o/o the PIO after he filed his second appeal before this Commission but complained that against most of his queries, the PIO did not furnish the documents but remarked as "not available and written to the EE, PHE & WS, Pasighat Division to furnish the report". When queried, the PIO replied that in response to his request to the EE, Pasighat Division, vide his letter dt. 11.09.2024 his office, at Likabali Division has received some of the documents which are ready for handing over to the appellant.

This Commission, upon hearing the parties and on perusal of the documents furnished by the PIO so far and the copy of correspondences made by the PIO with the EE, Pasighat Division, directed the appellant to go to the o/o the PIO at Likabali and collect the documents within **two days** from 09.04.25 and thereafter intimate to this Commission of his satisfaction or otherwise therewith within one week thereafter for further consideration of the appeal failing which it was made clear that the appeal shall be disposed of and closed presuming that he has received all the information and is satisfied therewith.

The appellant, vide his representation dt.16.04.2025, intimated that as directed by this Commission, he had visited the o/o the PIO but he found that the documents furnished by the PIO is incomplete and not as per his application as shown under:

(A) Project no. 1 & 2, information required as per Form-A are as follows:-

- (i) Serial no. 3: The information is incomplete as per the sanction amount.
- (ii) Serial no. 4,5,6,7,8 & 9: The information is not furnished.
- (iii) Serial no. 10:- The information is incomplete.
- (iv) Serial no. 12,13,14,15 & 16: Did not furnish the documents.

In view of the complaint of the appellant as above, this Commission decides to hear the appeal again on 23rd May, 2025.

NOW THEREFORE You are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the 23rd May, 2025 (Friday) at 2 pm with the left out documents/information and you are directed to produce on that day, all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
