**SUMMON.**

The 5<sup>th</sup> hearing held on **28<sup>th</sup> August, 2025** related to the **APIC No-216/2024**. The Appellant Shri Lenzing Pertin is present through online mode during the hearing before the Commission.

The PIO-cum-DLRSO, Pasighat, East Siang District, Govt. of Arunachal Pradesh is absent with a letter submitted to the Commission stating that he has furnished the remaining information(s) that was to be provided to the Appellant, as given below;

1. A new legible master map of Gumin Nagar area under Pasighat townwhip approved by competent authority.
2. Concept paper for allotment of land at Gumin Nagar area not available in the office.
3. PDF files of the land allotment orders at Gumin Nagar area, Pasighat furnished in a Pendrive (in electronic form).

**Heard the Appellant;**

The Appellant stated that he has sought the information(s) for a copy of the original master map of Gumin Nagar and not a map which is traced on a tracing paper. That he require a Xerox copy copied from the original legible master map of Gumin Nagar area under Pasighat town and regarding the concept paper for allotment of land at Gumin Nagar area for which the PIO has replied as not available with his office, the Appellant has requested the Commission to investigate the reasons why it not available with the office of the PIO, under the provisions of section 18(2) of RTI, Act, 2005.

As the PIO is absent, the fact of the matter could not be ascertained, and therefore, the Commission hereby orders as follows;

- (i) The PIO to provide scan/Xerox copy of the legible master map of Gumin Nagar area which is not traced out on a tracking paper, but copied from the original map.
- (ii) To order for investigation as to why concept paper for allotment for map of Gumin Nagar area is not available with the office of the PIO.
- (iii) To send summons to the PIO to be present in the next date of hearing to answer the contentions of the Appellant, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
- (iv) The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.

**The Commission hereby orders;**

**The next date of hearing be fixed on 9<sup>th</sup> December, 2025' at 1:30 PM (Evening).**
