**ORDER /SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Vijay Pertin and Shri Kalom Perme for non-furnishing of below mentioned information by the PIO, o/o the Deputy Director of School Education, DDSE, Namsai District, Govt. of A.P. as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 22.01.2025.

A. **Information sought for:** Appointment of PRTs, MTS, UDCs currently serving under Deputy Director of School Education, Namsai from 2016 to 2022.

B. **Details of information:**

1. Copy of the news paper cuttings where advertisements for the posts of PRTs, MTS, UDCs and LDCs were published for wide circulation in various years.
2. Copy of appointment orders of all the serving PRTs, MTS, UDCs and LDCs under DDSE, Namsai
3. Copy of all the submitted documents of the PRTs, MTS, UDCs, LDCs currently posted or serving under DDSSE, Namsai.
4. Copy of answer scripts of all the serving PRTs, MTS, UDCs, LDCs under DDSE, Namsai if they have appeared the interviews conducted by APSSB or Education department. If not appeared any interview then furnish in written statements.
5. Furnish in written statement if the mentioned above PRTs, MTS, UDCs and LDCs have not appeared any interviews and inducted into government jobs without facing any kind of interviews.

\* This appeal was heard on 12.09.2025 wherein the PIO, Shri Pokdey Yongam, DDSE and one of the appellants, Shri Vijay Pertin were present in person.

This Commission perused the documents/information brought in by the PIO and handed over to the appellant who was directed to go through the same and intimate this Commission of his satisfaction or otherwise therewith within 1 (one) week from the date of receipt of this order failing which, it was made clear, that this appeal shall stand closed without further order / notice.

This Commission is now in receipt of letter dated 22.09.2025 from one of the appellants, Shri Vijay Pertin who has expressed his dissatisfaction over the reply of the PIO, Namsai stating that the PIO has not furnished him the appointment letters of UDC and LDC serving under DDSE, Namsai as sought for by him at Sl. No.2 of his application. He has, therefore, requested for another hearing so that the PIO could be directed to furnish the left out information along with CTCs of appointment letter of PRTs and MTSs.

In the premises as above, the PIO is directed to furnish the left out information/documents and report the compliance therewith on or before the next date of hearing which is fixed on 24.10.2025.

**NOW THEREFORE**, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 24<sup>th</sup> October 2025 (FRIDAY) at 2 PM** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defence.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
