ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tap Sajan for non-furnishing of 7(seven) point information on implementation of Butterfly Park in Pakke Forest Division, Namdapha Forest Division and Ziro Forest Division by the PIO, o/o the Member Secretaries, A.P Bio-Diversity Board, Deptt. of Environment & Forest, SFRI Chimpu, Itanagar, Govt. of A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 06.02.25.

This appeal was, accordingly, listed on 12.09.2025 but none of the parties appeared. However, in the next date on 22.10.2025 the appellant, Shri Tap Sajan was present in person while Shri Ngilyang Tangu, Office Asstt. o/o the Member Secretary, AP Bio-Diversity Board, SFRI represented the PIO with some of the requested documents which were handed over to the appellant.

This Commission, upon hearing the PIO's representative and the appellant, directed the PIO to collect and furnish the following left out information/documents to the appellant:

- a) Names of the firms who participated in the tender process or through work orders (Sl.No.2);
- b) Colour photograph in respect of the Namdapha Forest Division (Sl.No.6) and
- c) Number of events celebrated till date (Sl.No.7)

The PIO was directed to furnish the left out document as above with proper seal and CTC and page marking separately for the 3 Divisions of Ziro, Pakke and Namdapha within 2 (two) weeks i.e on or before 4th November, 2025.

The appellant, however, informed vide his letter dt.06.11.2025, that the following information/documents have still not been furnished by the PIO:

1. Namdapha Butterfly Park, DPR, photographs of work undertaken, participating firms or work order.

In the premises as above, the PIO is directed to furnish the left out information / documents. It is made clear that if the o/o PIO does not hold the left out information, he shall furnish a declaration to that effect by way of an affidavit in terms of section-18(3)(c) of the RTI Act and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

The PIO shall comply with the above direction within 3(three) weeks and report the compliance thereof on 03.12.2025, the next date of hearing.

NOW THEREFORE, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 3rd Dec., 2025 (Wednesday) at 10.30 m** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.
