**WARNING SUMMON**

WHEREAS, in connection with the APIC-No. 649/2025, your personal appearances required before the Commission on **14<sup>th</sup> May 2026 at 10:30 AM**. - v) Notice for the next date of hearing need not be issued to the Appellant as he is present during the hearing before the Commission. Send notice to the PIO for the next date of hearing.
