ORDER / SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Basar Division, Leparada District(A.P) as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 02.12.2025.

A) Particular of information:

1. Pay Bill
2. T.A.DA
3. Muster Roll
4. Salary and Wages Allotment
5. Monthly expenditure
6. Salary/ Wages and posting order
7. LOC/Allotment
8. OC POL and OE

B) Details of information required:

8. Furnish a copy of pay bill of all months in the year 2022.
9. Furnish a copy of all T.A/ D.A bill and TTA Bill in the year 2022.
10. Furnish a copy of continuation order of muster Roll appointed by Superintending Engineer (S.E) Basar Circle, PWD, A.P and Executive Engineer (EE) Basar Division, PWD, A.P in the year 2022.
11. Furnish a copy of salary and wages posting order of each month in the year 2022.
12. Furnish a copy of LOC and allotment order of T.T/ D.A & TTA in the year 2022.
13. Furnish a copy of LOC/Allotment order of OC/OC POL and OE in the year 2022.
14. Furnish a copy of Expenditure details of OC/OC POL and OE in the year 2022.
 - a. Work order/ Supply order.
 - b. Counterfoil or cheque.

C) Period for which information is sought for: in regarding as per information sought.

Brief records emerging from the appeal :

Records in the appeal reveal that the appellant had requested for the aforementioned information from the PIO but failed to obtain the same which prompted her to file 1st appeal under section 19(1) of the RTI Act before the C.E (PWD), Central Zone-B, Pasighat, the First Appellate Authority (FAA) vide her memo of appeal dt.24.01.2026.

The appellant has also filed another appeal before this Commission vide her even dated Memo of application for the same information for the year 2024 and the appeal has been registered as APIC-311/2025. Since the two appeals pertain to same queries and concern the same PIO, the 2 appeals have been clubbed together and listed today on 07.08.26.

Records disclose that the FAA had conducted hearing of the appeals on 09.04.2026 but no records as to the order, if any, passed therein has been found in the appeals.

The appellant has, however, filed her 2nd appeals before this Commission under section 19(3) of the RTI Act, 2005 vide her Memos of Appeal dt. 23.03.2026. These appeals have, hence, been listed today on 07.08.26 wherein the appellant is present through VC while the PIO, Er. Shri Moji Padu, E.E is present in person.

Heard the appellant who submitted that the FAA had heard the appeal and passed order directing the PIO to furnish the requested information but the PIO failed to comply with the direction of the FAA. The appellant, however, could not give the details of the hearing and the order passed by the FAA, neither the PIO produced any record thereof.

In the premises as above, the hearing of this appeal is adjourned to 18.09.26 and in the interim, the PIO is directed to furnish to the appellant the requested information in respect of both the appeals and report the compliance thereof to this Commission on that date.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined, including closure of the appeal, in your absence.
