**SUMMON**

WHEREAS, in connection with the **APIC-No. 759/2025**, your personal appearance is required before the Commission on **14<sup>th</sup> May, 2026 at 10:30 AM**. The 1<sup>st</sup> hearing held on **24<sup>th</sup> February' 2026**. The Appellant Shri Tagi Ruti, found absent during the hearing and PIO-cum Executive Engineer, WRD, Likabali, Lower Siang, District also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and hereby orders;

- i) To **issue summons** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- ii) To **issue summon** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which this appeal shall be heard and determined ex-parte.**

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

**The next date of hearing be fixed on 14<sup>th</sup> May 2026 at 10:30 AM (Morning).**
