### SUMMON.

**WHEREAS**, in connection with the APIC-No. 829/2023, your personal appearance is required before the Commission on 26<sup>th</sup> March, 2026 at 10:30 AM. The 4<sup>th</sup> hearing held on 18<sup>th</sup> November, 2025. The Appellants Shri Palen Laa & Smti. Yukar Yage are absent without intimating the reasons for their absence to the Commission.

The PIO-cum-EE, Power (E) Raga Division, Kamle District, Govt. of Arunachal Pradesh is represented by Shri Tarh Takap, Junior Engineer (JE), Electrical, Raga Division, Kamle District, during the hearing before the Commission.

#### **Heard the representative of the PIO;**

The representative of the PIO stated before the Commission that a part of Raga Division used to function from Ziro Electrical Division and another part used to function from Daporijo Electrical Division, before March' 2019.

The regular Raga Electrical Division started functioning from the month of March' 2019 only. The Appellants have applied for information before 2019, before the Raga Division started functioning.

And therefore, whatever information available with the Executive Engineer Daporijo Division and Ziro Division had already been furnished to the Appellants by the PIO-cum-Executive Engineer, Power, Electrical, Raga Division.

The PIO-cum-EE, Power, Electrical, Raga Division furnished the information which are available in the office of the PIO to the Appellant and if the information furnished are alleged to be incomplete, the PIO-cum-EE, Power (E), Raga Division does not have any further clarification on this issue and no other information are available as applied by the Appellants in the office of the PIO-cum-EE, Power (E) Raga Division because the PIO has provided whatever information available with the PIO's office to the Appellants.

After hearing the representative of the PIO the Commission hereby orders;

- i) The Appellants to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- ii) The PIO-cum-EE, Power (E), Raga Division to be present in the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- iii) Notice be sent to the Appellants for the next date of hearing to be present in the next date of hearing in person or through online mode.
