As per the order dated 28/04/2025, the information sought was brought before the Commission but could not be handed over to the appellant due to his absence. The case was disposed and direction was given to the appellant to collect the information from the office of the PIO-cum-EE(PWD), Palin.

Complaint was made before the Hon'ble Chief Information Commissioner for disposing the case. The appellant has submitted an application for not providing the information by the PIO. The PIO is directed to provide the information as per Form 'A' Application which was not provided earlier. If intimation is not given by the appellant, the Commission will presume that he has been provided all the information and is satisfied and the appeal case will be decided even if he is not present.
