## Summon Notice.

The 6<sup>th</sup> hearing of <u>APIC-417/2023</u> is held on 22nd <u>January,2024</u>. The appellant Shri Tasi Chader present during the hearing but the PIO found absent.

The appellant intimated to the Commission that till date no any information has furnished to him by the PIO.

After going through all the available records & documents, the Commission found that the PIO intimated to the Commission in the last hearing that all the information which sought by the appellant in his form A application are available with the PD-cum-DRDA, Daporijo. So, he requested the Commission to send summoned notice to the PD-cum-DRDA, Daporijo as he is the answerable regarding the matter.

The Commission asked the PIO, why he failed to transfer the APIC-417/2023 immediately after receipt of the application from the appellant within 5 days as per the RTI Act,2005. But the present PIO could not reply on this matter. Rather, he requested to issue summon notice to the PD-Cum-DRDA, Daporijo during next hearing i.e 04.12.2023.

The Commission served the Summoned notice to the PD-Cum-DRDA, Daporjo dated on 16/10/2023 and 04/12/2023 to appear before the Commission during the hearing, but the PIO failed to comply the direction of the Commission.

The Commission viewed seriously on the reluctant attitude shown by the DRDA, Daporijo and also he failed to comply the direction of the Commission.

Therefore, the Commission directed to issue show cause to the DRDA, Daporijo to appear before the Commission in the next date of hearing and also directed to furnish all the information to the appellant related to the APIC no-417/2023 on or before next date of hearing. Failing which Section 20 (1) shall be initiated against the DRDA, Daporijo as per the RTI Act, 2005.

The Commission fixed the next date of hearing on 3<sup>rd</sup> April, 2024 at 2 PM.
