**The 1<sup>st</sup> hearing** was held on **27<sup>th</sup> May, 2026** related to the **APIC No-809/A/2025 (Appeal)**. Both the parties appellant Shri John Tara Bakey and the PIO-cum-Dy. Director, Panchayati Raj present in person.

PIO has stated today that the hearing was conducted before the First Appellate Authority but appellant did not attend the hearing in spite of giving summon notice. The appellant is directed to seek specific information by submitting in writing to the PIO as per his original Form 'A'.

The Commission adjourned the hearing and fixed next date of hearing on **08/07/2026 at 2 PM**.
