SUMMON

WHEREAS, in connection with the **APIC-No. 932/2025**, your personal appearance is required before the Commission on **29th September, 2026 at 02:30 PM**. The 2nd hearing held on **16th July'2026**. The Appellant Shri Tarh Rohan, absent during the hearing and the PIO-~~o/o~~- Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB) Itanagar is also absent during the hearing.

Heard the Appellant;

The Appellant absent with a letter submitted to the Commission dated 26/5/2026 submitting that the PIO has provided insufficient information as committed in the first hearing.

The PIO-Cum- Registering Officer, Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB) Govt of Arunachal Pradesh Itanagar, was present in the first hearing and prayed that 3(three) weeks time be given to provide the information to the Appellant.

In the absence of both the parties, the Commission while going through the letter submitted by the Appellant and considering the prayers by the Appellant pass the below orders;

- i) PIO to furnish the information to the Appellant on or before the next date of hearing without fail. In the event of not furnishing the information completely to the Appellant, the Commission will impose penalty upon the PIO.
- ii) The Appellant to approach the office of the PIO to collect the information from the office of the PIO on any working day.
- iii) **To send summon to the PIO, to attend the hearing in the next date without fail, failing which appropriate action as provided under RTI Act 2005 will be initiated against the PIO.**

- iv) The Appellant to be present in the next date of hearing without fail, **failing which the Commission will presume that the Appellant has received the complete information from the PIO and thereby this appeal will be heard and determined ex-parte by way of disposing this appeal.**
- v) To send notice to both the parties for next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 29th Sept'2026 at 2:30 PM (Evening).

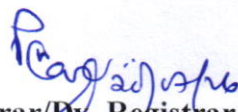
