**Summon Order**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, for non-furnishing of information by the PIO –cum-EE, PWD Yingkiong Division, Upper Siang District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The last hearing of this case was held on 24<sup>th</sup> Jan,2024 (Wednesday). The Appellant was present and the representative of the PIO Shri J.P Pandey, ASW, PWD Division, Yingkiong was also present. During the hearing of this case, the appellant requested the Court to direct the representative of the PIO to furnish the information pertaining with SIDF Schemes only for the periods of 2018-19,2019-20 and 2020-21 its Sanction Orders Copies etc as per his Form A. Accordingly the Commission directed the representative of the PIO to furnish the same to the appellant and after its completion the PIO/APIO should communicate with the appellant and the appellant should also approach the PIO's Office for collecting the sought information and after going through the information he should inform his satisfaction / dissatisfaction to the Court / Commission for further proceeding into the case.
