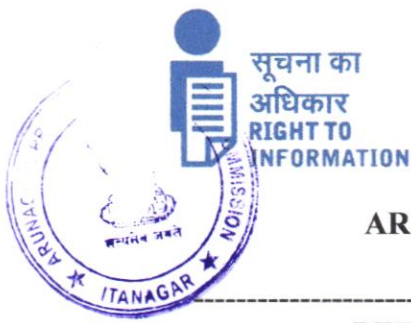

Take notice that in default of your appearance on the date and time mentioned above the case shall be heard and decided in your absence.

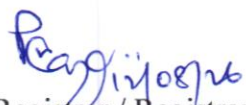
