## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tajing Saroh, Vill, Sipeng, Jomlo, Circle, PO/PS Rumgong, District Siang, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-DDSE, Govt. of A.P. o/o of Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/11/2022 regarding Certified True copy of the Appointment order, appointment Letter and Official advertisement no. of the PRT(ISSE) of Siang District.

The 3<sup>rd</sup> hearing is held today on 6<sup>th</sup> February; 2024 (Tuesday) at 1030 hrs. Both parties are present. The Smty O.B. Tatak, the SPIO-cum-DDSE, Govt. of A.P. o/o of Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh has submitted that the application in form "A" was not received by her and requested the Appellant to provide the application of 21/11/2022 so that she can furnish the information as soon as possible. The Appellant agreed to furnish the copy of application form "A" to the SPIO and the SPIO assured to provide the information as early as possible on receipt of the application. The Commission directs the Appellant to provide the application within 5 days from the date of issue of this order and SPIO is directed to furnish the information within 15 days from the date of issue of this order. The court is adjourned to 9<sup>th</sup> April' 2024 (Tuesday) at 1030 hrs.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal provision and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is no more interested with the information.

The next date of hearing is fixed on 9th April' 2024 (Tuesday) at 1030 hrs.

Therefore, the SPIO-cum-DDSE, Govt. of A.P. o/o of Deputy Director of School Education, Boleng, Siang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
