ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 13(thirteen) point information by the PIO, o/o the Executive Engineer (RWD), Aalo Division, West Siang District (A.P) Construction / upgradation of roads and Bridge under Pradhan Mantri Gram Sadak Yojana at following locations during the financial year 2024-25:

1. BRTF Road to Kugi Pomse.
2. Gadi Mesi to Kagi Gadi
3. MRL 10-Pakam to Ushi via Kombo Pomte.
4. Doji jeku to Ngomdir.
5. Liromoba HQ to VKV School.
6. Darak to Belo.

as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 05.02.2025.

Facts emerging from the appeal:

The records in the appeal reveal that the appellant failed to obtain the requested information from the PIO which prompted him to file his 1st appeal under section 19(1) of the RTI Act before the CE (RWD)(WZ), Itanagar, the First Appellate Authority (FAA) vide his memo of appeal dt.18.03.2025. But having failed yet again to receive any positive response from the FAA, the appellant preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act 2005 vide his Memo of Appeal dt.19.07.2025.

This appeal was, accordingly, listed and heard on 03.10.2025. But the PIO was absent without any information though the appellant, Shri Tamchi Gungte was present in person who expressed his disappointment on the non appearance of the PIO and demanded action under the relevant provisions of RTI Act.

This Commission, viewing seriously the absence of the PIO, adjourned the hearing of this appeal to 12.11.2025. However, the appellant did not attend the hearing today without any intimation.

The PIO, Er. Shri Gambi Karbak, EE is, however, present in person with the replies to the RTI queries of the appellant. But since, the appellant is absent, the replies furnished vide letter dt.06.11.2025 by the PIO could not be handed over to the appellant and the appeal could not be heard.

In the premises above, the hearing of this appeal is adjourned to 16th January, 2026 and in the mean time the replies furnished by the PIO shall be handed over to the appellant as and he visits this Commission.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 16th January, 2026 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
