SUMMON.

WHEREAS, in connection with the APIC-No. 359/2024, your personal appearance is required before the Commission on **10th March, 2026 at 01:30 PM**. The 3rd hearing held on **30th October' 2025**. The Appellant Shri Khya Changrang is absent with a letter of absence. The PIO is present through online mode during the hearing before the Commission.

Heard the PIO;

The PIO stated before the Commission that he has been transferred from Rupa, SE, RWC, West Kameng District to SE, Design and Planning, Itanagar, Govt. of Arunachal Pradesh.

The PIO stated that the Appellant has filed the said RTI Application for which the Second Appeal is registered and being heard by the Arunachal Pradesh Information Commission (APIC) now, is due to the fact that there was a tender by the name of work Lo27-Road from Crema Pao Road to Raro Sollung Parag No. AR/03/03/0268, wherein the Appellant represented the Firm Ragia Ku Enterprises and the same Firm was disqualified due to technical reasons. I, being the Chairman of that tender opening committee was targeted by the instant Appellant, Shri Khya Changrang, and after that the Appellant has filed RTI seeking all the information(s) about my service records appointment, transfer, posting and even leave obtained. This application is purely filed by the vested interest of the Appellant. Due to the reason that the tender committee had rejected the firm represented by the Appellant in this appeal. I being the Chairman of this said tender committee now bears the brunt by the misuse of RTI application for personal vengeance.

The Commission observes;

After hearing the PIO the Commission severed the SE, Rupa, RWC, West Kameng, as a party from this instant appeal. The present party to this appeal shall only be the Superintending Engineer (SE) Design and Planning, Itanagar, Govt. of Arunachal Pradesh.

In the absence of the Appellant the Commission could not proceed the hearing and fixed another date for hearing.

After hearing the PIO and going through the Form-A application of the Appellant: **the Commission hereby orders;**

- i) The PIO to be present in the next date of hearing in person or through online mode without fail, failing which necessary action will be initiated against the PIO as provided in the RTI, Act, 2005.
- ii) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this instant appeal will be heard and determined ex-parte.
- iii) Notice be issued to the Appellant for the next date of hearing.
- iv) Notice need not be issued to the PIO as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 10th March' 2026' at 1:30 PM (Evening).
