ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri TakamSakap, C/o Hotel 3D Chandanagar, Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(WRD), Govt. of A.P., Water Resource Department, Bordumsa Division, Changlang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/05/2023 regarding "SIDF/Additional (SIDF) BE / Additional (BE) / RE / Additional (RE) / SADA / ADA / MLA LAD / MPLAD / CCI / SPA /SJETA/CMCSR or Maintenance and Supply Works / order for implement of developmet at EtireBordumsa Division from 2017 to till date.

The 2nd hearing is held today on 27th February, 2024 as scheduled. The SPIO-cum-EE(WRD), Govt. of A.P., Water Resource Department, Bordumsa Division, Changlang District, Arunachal Pradesh is represented by Adv. T.Lamgu. The appellant shri Takam Sakap is present. In compliance with the direction of the commission the the PIO has furnished list of schemes under SIDF for the financial year 2022-23. After a long argument the appellant has agreed to seek information of SL.No. 5 of the list, i.e. Plugging structure and river channelization of Nao-Dihing River gibbon, Bordumsa, sanctioned vide SWRD-287/SIDF /BDM/2022-23/Dt.28/02/2023.

The PIO is directed to furnish relevant information of the scheme as given above within 28 (twenty eight) from the date of issue of this order. The appellant is directed to keep in touch with the PIO and collect information from the office of the PIO. The information should be provided free cost.

Both the parties are directed to appear before the commission's court on the next date of hearing. In case the PIO remains absent the penal provision under section 20(1) of the RTI Act 2005 shall be imposed on him. In case the Appellant remains absent the case shall be disposed of without any further notice presuming that the Appellant has received information and is satisfied with the information furnished by the SPIO's. The court is adjourned for the next date of hearing.

The next date of hearing is fixed on 9th April, 2024 (Tuesday) at 1030 hrs.

Therefore, the SPIO-cum-EE(WRD), Govt. of A.P., Water Resource Department, Bordumsa Division, Changlang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
