APPELLANT : Shri Yorri Pale, Abe Village.

RESPONDENT : The PIO, o/o the EE (RWD), Aalo Division, West Siang District.

ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Yorri Pale for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Aalo Division, West Siang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 24.06.2025.

Details of information required:

1. Total amount of sanction against Esc Abe C.C steps under SIDF 2023/2025
2. Total payment amount;
3. Name of the farm under the works executed;
4. Date of payment of bills with Xerox copy of bills;
5. Date of tender and its executed farms;
6. Details of payment to the farms owner and
7. Length of the works to be carried out and to be execute by the awardee.

This appeal was heard on 13.03.2026 wherein the appellant, Shri Yorri Pale was present in person while, the PIO, Er. Shri Mojum Kamki, EE appeared through VC.

This Commission, upon hearing the PIO who submitted that the requested information are ready for furnishing to the appellant, directed him to dispatch the information/documents through Speed Post to the appellant (as requested by him) within 1(one) week from the date of receipt of the order dt.13.03.2026 and the appellant was also directed intimate this Commission of the receipt of the information within 1(one) thereafter for further consideration of the appeal.

It is, however, seen from the appellant's letter dt.10.04.2026, as reproduced hereunder, that the PIO did not dispatch the information/documents as assured.

"Respected Sir,

I, the undersigned, most respectfully beg to submit as follows:

1. *That the present matter pertains to Case No. APIC-815/2025 pending before this Hon'ble Commission.*
2. *That the matter was listed on 13.03.2026 before this Hon'ble Commission, and the Respondent/PIO was directed to furnish the sought information/documents to the Appellant within one week from the said date.*

3. That despite the clear direction of this Hon'ble Commission, the Respondent/PIO has failed to furnish the said documents/information to the Appellant within the stipulated time.
4. That no communication or reasonable cause has been provided by the Respondent for such non-compliance till date.
5. That the act of the Respondent amounts to wilful disobedience of the order of this Hon'ble Commission and defeats the very purpose of the RTI Act, 2005.

PRAYER

In view of the above facts and circumstances, it is most humbly prayed that this Hon'ble Commission may kindly

- A. Take appropriate action against the Respondent/PIO for non-compliance of its order;
- B. Direct the Respondent to furnish the complete information/documents immediately, and
- C Pass any other order(s) as deemed fit and proper in the interest of justice.
