SUMMON-CUM-ORDER.

The 1st hearing was held on **1st June, 2026** related to the **APIC No-842/A/2025 (Appeal)**. The PIO, O/o the Principal, Government College Doimukh present in person but the appellant found absent without any intimation to the Commission.

PIO stated that the information sought by the appellant had already been replied to RTI Application on the same information requested by the appellant.

The First reply was given on 29/07/2024. Second reply was given on 16/04/2025 through register post. But the appellant has repeatedly sought information to RTI on the same matter by slightly altering the request of information.

So the information sought was not considered necessary to give reply to this 3rd RTI application on the same information but slightly altered.

PIO referred to CIC's decision in Vijay Prakesh Vs CPIO-cum-Income Tax Officer, Bangalore. Shri Ramesh Chand Jain Vs Delhi Transport Corporation. In which the Hon'ble CIC decided that there is no scope of repetition under RTI Act. Citizen has no right to repeat. Repetition shall be ground of refusal. Appeal can be rejected.

The appellant is directed to be present in person before the Commission in the next date of hearing and reply the representation made by PIO that why his appeal case should not be rejected on the ground of repeatedly seeking same information from same institution.

Commission adjourned the hearing and fixed next date of hearing on **08/07/2026 at 2 PM.**
